



## STUDENT CODE OF CONDUCT and RELEASE

**IMPORTANT: NO STUDENT WILL BE ALLOWED TO AUDITION OR PARTICIPATE AT THE ALL STATE WEEKEND WITHOUT THIS FORM COMPLETED AND SIGNED**

- 1 When outside their room but on the hotel property or at the concert venue, students must wear their TPSMEA name badges.
- 2 Students will be on time for all rehearsals and performance. A tardy of 15 minutes or less receives a warning. A second tardy or a tardy of over 15 minutes is considered an absence and constitutes grounds for a student's dismissal from the ensemble.
- 3 A student must be eligible for participation according to the policies and procedures associated with the student's school.
- 4 Students must remain reasonably quiet at all times in the hotel. TVs, CD players, etc. must be played at low volume levels.
- 5 There shall be no defacing of hotel property. Any damages to the property or furnishings in the hotel rooms or concert venue must be paid for by the individuals responsible.
- 6 Hotel room doors should be locked at all times.
- 7 **Boys are not allowed to visit girls' rooms; girls are not allowed to visit boys' rooms.** If it is necessary to make an exception, a chaperon must be present.
- 8 **Curfew for all students is 10:00 PM.** The curfew means that students must be in their assigned rooms and not leave them after this time. This curfew is in force Thursday through Saturday night. If it is necessary to make an exception, a chaperon must accompany the student.
- 9 Possession or use of alcoholic beverages or controlled substances (drugs or illegal materials) will not be tolerated.
- 10 No practicing or playing instruments in the hotel area after 7 PM.
- 11 The student's director/sponsor shall be responsible for enforcing any additional school overnight travel policies.
- 12 The student must attend all rehearsals and the ensemble's performance. Should a conflict arise which prevents the student's participation in any part of a rehearsal or performance, whether athletic event, SAT test, family obligation, etc., the student will lose membership in the ensemble and will not be allowed to participate in any subsequent rehearsal or performance and will not receive an All-State patch.

It is understood by students and parents that any infraction of the above rules of conduct or involvement in any illegal activity constitutes grounds for the student's dismissal from the All-State Clinic/Concert. The parents will be contacted and asked to make immediate arrangements for their student's transportation home.

Students are responsible for their own property at all times. Liability for loss of property, whether by fire, theft or vandalism is limited to the student and their school. All expenses incurred attending the All-State weekend, including but not limited to, hotel, meals and transportation are the responsibility of the student and the student's school. All students must stay at the designated TPSMEA hotel.

You acknowledge and agree that you are voluntarily assuming all risks of exposure to COVID-19 and agree to release, waive and discharge TPSMEA, its officers, directors and members, and all related and affiliated individuals and entities involved in the All-State Clinic/Concert which you are attending, from all claims directly or indirectly arising from your participation in TPSMEA All-State Clinic/Concert.

I agree to support and abide by the above rules of conduct. I further agree that access to student's room and baggage will be given upon request to a designated TPSMEA official. I also give permission to TPSMEA to use my name and photographic likeness in all forms and media for advertising, trade, and any other lawful purposes.
